The purpose of Pre-Employment Transition Services (PreETS) is to assist students with disabilities to have the opportunity to explore the world of work and other services necessary to transition from school to post-secondary education.

By signing this form it is understood that you are going to receive one or more Pre-Employment Transition Services. These services include:

1. Job exploration counseling
2. Work based learning experiences, which may include in-school or after school opportunities, or experience outside the traditional school setting (including internships), that is provided in an integrated environment in the community to the maximum extent possible
3. Counseling on opportunities for enrollment in comprehensive transition or postsecondary educational programs at institutions of higher education
4. Workplace readiness training to develop social skills and independent living
5. Instruction in self-advocacy (including instruction in person-centered planning), which may include peer mentoring (including peer mentoring from individuals with disabilities working in competitive integrated employment)

If it is determined that you will require additional services beyond those listed above, you will be asked to apply for the full Vocational Rehabilitation program and meet all eligibility requirements. By signing this document, it is understood the information gathered during the provision of Pre-Employment Transition Services will not be disclosed to another party without prior written consent.
