Important Data Notes

Compliance Indicators

- Targets and scoring criteria (e.g., what constitutes a score of 0, 1, 2, and 3 for a given indicator) stayed the same for Indicators 4B, 9, 10, and 20.
- The cut scores for Indicators 11, 12, & 13 changed.

3	100.00%	95.00-100%
2	95.00-99.99%	90.00-94.99%
1	70.00-94.99%	70.00-89.99%
0	<70.00%	<70.00%

Important Data Notes

Compliance Indicators

- The valid and reliable component was added.
- It is worth up to 1 point.
 - If your data is valid and reliable (as determined by the 7 infractions we check), then you receive 1 point.
 - If you have one or more infractions, you receive 0 points.
- 7 infractions have to do with service school IDs and LRE codes not matching (as reported on 684); Indicator 11 data inaccuracies (as reported on the self-assessment); and missing data submissions.

Important Data Notes

Results Indicators

- The **targets** on all results indicators changed, and thus, the cut score for 2 points changed.
- The cut scores for 0, 1, and 3 points did not change.

Scoring Criteria

- Scoring criteria for the four categories for the overall, compliance, and results section did not change this year.

Category	Compliance	Results	Overall
Meets Requirements	100.00%	66.00-100%	75.00-100%
Needs Assistance	85.00-99.99%	51.00-65.99%	59.50-74.99%
Needs Intervention	70.00-84.99%	6.00-50.99%	22.00-59.49%
Needs Significant Intervention	0.00-69.99%	0.00-5.99%	0.00-21.99%

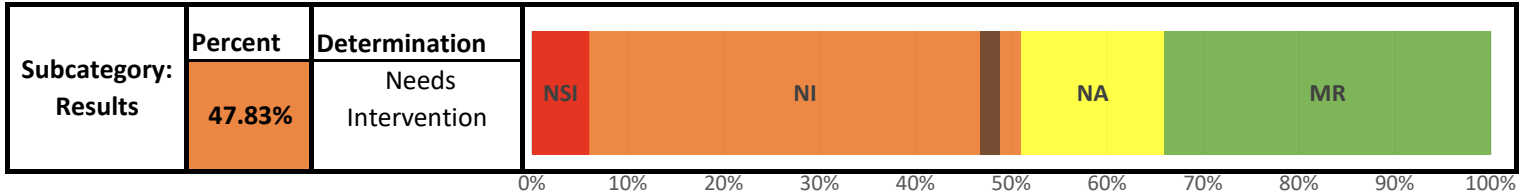
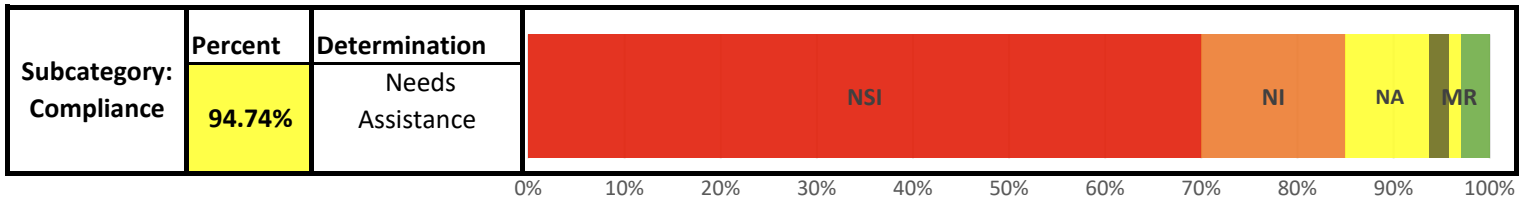
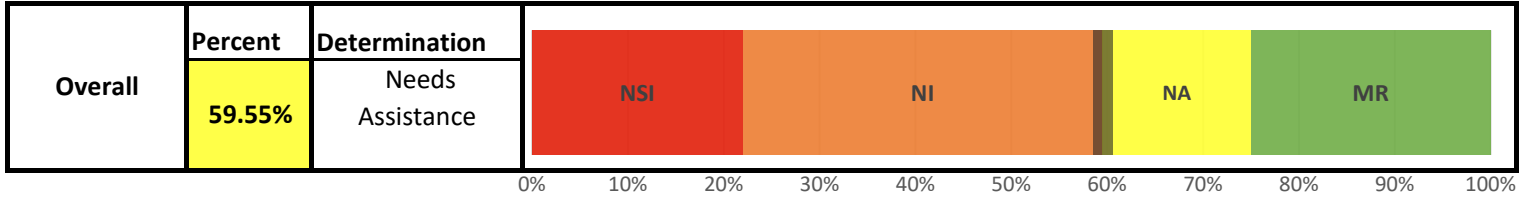

Example

LEA Determination: Needs Assistance



Determination Levels, Percent Score

Overall

- 75.00-100% = Meets Requirements
- 59.50-74.99% = Needs Assistance
- 22.00-59.49% = Needs Intervention
- 0.00-21.99% = Needs Substantial Intervention

Overall Determination is calculated by giving the Compliance score 25% of the weight and the Results score 75% of the weight.
